SELECTMEN'S MEETING MINUTES

January 29, 2016

The meeting was called to order at 8:30AM by Chairman Harris. Present were Selectmen Mrs. Paight and Ms. Pitt, and Administrative Assistant Ms. Booth.

ADMINISTRATIVE ITEMS

Mrs. Paight moved and Ms. Pitt seconded the motion to accept the two sewer abatements that were submitted to the Selectboard. Vote to approve was unanimous. Abatements were signed.

Mrs. Paight moved and Ms. Pitt seconded the motion to accept the CNP accessing contract submitted to the Selectboard. Vote to approve was unanimous. The contract was signed.

The Selectboard reviewed an Intent To Cut. It was determined a clarification on the signature would be needed. Correspondance to the person who submitted the Notice of Intent to Cut will be sent, requesting needed information.

The Selectmen reviewed correspondence from the Board to Ms. Dennis regarding her email submitted to the Selectboard.

The Selectmen discussed the water and sewer 2016 proposed budgets.

Discussion of warrant articles to be included in the 2016 proposed budgets took place.

Discussion of parking on Canada Street took place. Parking on both sides of the street near the Summit Recreation business has been occurring making it impossible for a truck to get through. This road is a designated truck route. Chief Lyons joined the meeting at 10:40AM and the discussion of the parking on Canada St. In the case of an emergency, if emergency vehicles needed to access that area while cars were parked on both sides, they would be unable to do so. The Selectboard will reach out to the owners of Summit Recreation and let them know of the situation. Chief Lyons left at 11:05AM.

Discussion on donations or requests made by non-profit charities included in the budget took place. All requests will not be placed in warrant articles.

Ms. Pitt excused herself from the meeting at 10:30AM.

The Selectmen continued discussion on the 2016 proposed budgets.
